# JAVITS PROGRAMMATIC AND GRANT ADMINISTRATION – BEST PRACTICES AND REMINDERS



- ▶ **G6 replaced G5 as grant administrative and fiscal management system.**
- ▶ **Performance and Budget Reporting:**
  - ▶ **Project-Specific Performance Measures**
  - ▶ **Javits Program Performance Measures**
    - ▶ No longer referring to Government Performance and Results Act (GPRA)
    - ▶ No changes were made to the performance measures published in respective NIAs for each cohort.
    - ▶ Information about compliance with project and program performance measures can be found in the Education Department General Administrative Regulations (EDGAR) Part 75, section 110.
  - ▶ **Budget and Revisions**
    - ▶ Work with your Program Officer for revising budgets
- ▶ **Annual Reporting Requirements:**
  - ▶ Annual Performance Report (APR) – Due May 31, 2024
  - ▶ Ad Hoc APR – Due October 31, 2024
